

SIGNING INSTRUCTIONS – VERY IMPORTANT!

1. **Print the Petition Properly**
 - The petition **must be printed double-sided (front and back) on a single sheet of paper.**
 - **DO NOT** print the front and back on two separate sheets.
2. **Eligibility to Sign**
 - All signers must be **18 years or older** and **registered to vote in the State of Maryland.**
3. **Print Your Information Exactly as Registered**
 - Use your **full legal name — First, Middle, and Last Name** — exactly as it appears on your Maryland Voter Registration.
 - You can verify your information at the [Maryland Voter Registration Website](#).
4. **Signature Must Match Voter Records**
 - Your **signature must match** your name on your voter registration and the name you printed on the form.
 - Your signature **must be legible.**
5. **Complete All Fields Clearly**
 - **Print clearly** in all fields on the petition.
 - All information must be **complete, accurate, and legible.** Incomplete or illegible entries will be invalidated.
6. **Complete the Circulator's Affidavit**
 - After signing, you **must fill out the Circulator's Affidavit** at the bottom of the petition.
 - Use your **full legal name as registered** and write clearly and legibly.
 - Even if you are only signing your own petition, **you are your own circulator** and must affirm this.
7. **Return Your Petition**
 - Completed petitions must be returned to FARM **on time** using one of the following methods:
 - **By Mail:** Must **arrive no later than Friday, May 30, 2025.**
 - **Drop-Off:** Must be **delivered to a drop-off location by Sunday, June 1, 2025.**

8. **Deadline Reminder**
 - In order for your signature to be valid, we **must have your completed petition in our possession no later than June 1, 2025.**

INSTRUCTIONS FOR CIRCULATORS

1. **Carry a Copy of the Bill**
 - You **must have a full printed copy (front and back) of SB931** (38 pages) available for anyone who wishes to review it before signing.
 - **Do not collect signatures without this on hand.**
 2. **One County Per Sheet**
 - Write the **county name** where you are collecting signatures in the **upper left-hand corner** of the petition sheet.
 - **Do not mix counties** on one sheet — use separate sheets for each county.
 3. **Fill Out the Bottom Section**
 - As a circulator, **print your full name, address, and phone number** at the **bottom left corner** of each petition sheet.
 - **Sign and date** the form.
 4. **Submit Completed Petitions**
 - Drop off completed sheets to a local coordinator, or a drop-off location.

 5. **Deadline**
 - **All completed petitions must be received by June 1, 2025.**
 - If mailing, ensure they **arrive by Friday, May 30.**
 - If dropping off, confirm **location hours of operation** and deliver by **Sunday, June 1.**
